#### A MESSAGE FROM OUR EXECUTIVE DIRECTOR



On behalf of the Monmouth County SPCA, I'd like to thank all of our supporters for their dedication and outpouring of generosity. Thanks to your support, we are well on our way to meet and surpass our 2017 goals. This past April, we celebrated our **24th Annual Dog Walk + Pet Fair** at Brookdale Community College where we rasied over \$100,000 for the homeless, neglected and abused animals of Monmouth County. Our **Animal Control Division** continues to grow and thrive in our community, supporting our mission to control animal over-population in our county. In 2017 alone, our TNR team responded to hundreds of calls and have helped over 1,160 community cats receive spay/neuter surgeries. Our shelter programs continue to outperform the already high expectations we have for them. Our adoption numbers are up and already on track to beat the numbers of 2016 - that means more than 5,000 animals will be saved this year alone!

We are able to fulfill our mission **because of YOU!** Your continued support allows us to provide shelter, medical attention, compassionate care and a safehaven for thousands of animals as they await adoption. Although we are making a huge difference for the animals of Monmouth County and beyond, there are so many more in need of our help!

### **Homeward Bound**

Six years ago the Monmouth County SPCA embarked on a special mission to open the eyes of the public to the horrors of puppy mills. With support from our partners, including the Humane Society of the United States and St. Hubert's Animal Welfare Center, we were able to develop a business model and create a satellite location to serve as a rescue puppy adoption center. The goal of opening our Freehold Adoption Center was to rescue as many animal lives as we could from struggling, over-crowded shelters and create an alternative to the purchase of dogs from puppy mill breeders.

Throughout the past six years, 116 New Jersey municipalities have either adopted ordinances or completely banned the retail sale of cats and dogs, which has created a forward motion to encourage more New Jersey regions to do the same.


The Monmouth County SPCA feels the goal of bringing awareness to the mission of stopping puppy mills has been successful, therefore; we will be relocating our rescue puppy operation and bringing them home to our Homeward Bound Adoption Center in Eatontown. We are thankful for the hard work our Freehold Adoption Center has contributed to help convey our message to the public.

We will not stop our efforts to end puppy mill practices and will continue to rescue and save the lives of these beautiful, innocent animals who otherwise would have no real chance of making it out of their home shelter alive. In addition to maintaining the number of animals rescued, we will continue to recirculate portions of adoption fees back to the original shelter to help support spay/neuter efforts to prevent over-population.

We want to thank everyone who has done their part to support our mission to protect and advocate for all animals. We are dedicated to enforcing animal cruelty laws; providing a safe-haven for homeless, abused and abandoned animals while they await adoption; reducing animal over-population through spay/neutering; and cultivating their humane treatment through education and advocacy services as a valuable community resource.

With your compassion and support, we have saved **thousands of innocent lives** through our Freehold Adoption Center and will continue to watch those numbers grow through our home shelter in Eatontown.

#### MCSPCA Law Enforcement Division Moves to Prosecutor's Office

The Monmouth County SPCA Humane Law Enforcement Division has officially been relocated to a division out of the Monmouth County Prosecutor's Office. The move was a precedent to comply with a new state law on animal cruelty enforcement. In compliance with the new law, Monmouth County has established an Animal Cruelty Hotline for residents to utilize. The new number will serve as a conduit for calls to be directed into the Animal Cruelty Division of the Monmouth County Prosecutor's Office. The Monmouth County SPCA is the first organization among New Jersey Counties to initiate a dedicated line and continues to set the gold standard for other Law Enforcement Divisions to model.

### A Strange Looking Visitor in Colts Neck

A heartwarming rescue story for a young buck! A homeowner in Colts Neck, NJ called us to alert us of a young buck who had a glass bowl stuck on his head. The deer had been ostracized from his herd since he looked different with the bowl on his head and would only come to feed once they had all gone, which is when he was noticed. Our Humane Law Enforcement in cooperation with the **NJ Division of Fish and Wildlife** waited for the buck to appear again and humanely sedated him to save his life. After he was safe to approach, the glass bowl was removed, which turned out to be a light fixture cover that was most likely filled with water the deer tried to drink. The buck was dehydrated from 4 days without food and water and had a couple of scrapes probably from the poor visibility but was able to get up and walk away after we cleaned him up and the sedative had worn off. We're thankful we have such a dedicated team of professionals who go above and beyond for all species and we can do it all because of supporters like you!



### A Microchip Miracle

Who doesn't love a good reunion story? Whiskers arrived at the MCSPCA over the winter as a stray; he was in great condition and obviously well cared for but unfortunately the number associated with his microchip was disconnected. Our staff members knew someone had to have been missing this kitty so we did some online detective work! We looked up the name associated with the microchip number and tracked down Whisker's owners on Facebook. It turns out the family moved and Whiskers got out of his new home and couldn't find his way back. As soon as we messaged the family they rushed in to redeem him - look at these happy faces! Whiskers was a lucky one, but there are hundreds of animals who come into the shelter with unregistered or outdated microchips every year. A simple phone call to your microchip service provider can save a life! And like we always say, the power of social media is amazing!

### Installation of New MCSPCA Board Members





## Transformation Times Two





Pookie and Riley recently came to the shelter in extremely poor shape. Both dogs were matted, Pookie to the point of **strangulation to one of her legs**, causing an infection in the bone. Sadly her other leg was dangling due to a previous, untreated injury and would need amputation. Riley, the larger of the two, came with a grapefruit sized, necrotic mass on her neck, which was too graphic to publish. Both girls had severe periodontal disease, infected ears and anemia and required an aggressive treatment plan to help their health and condition improve. Thanks to all of our wonderful supporters, including a generous donor who matched all donations over Memorial Day Weekend, Pookie and Riley were able to receive the **compassionate care** they so desperately needed. Both girls were shaved and bathed to start, instantly giving them relief! Pookie had her front leg amputated at Garden State Veterinary Hospital with help from an additional donor and Riley had her tumor completely removed, leaving behind just a small scar. And now for the happy ending! Sweet Pookie was adopted by one of the technicians that cared for her during her hospital stay and is already the most spoiled girl. Riley spent only a week at our shelter before she met a wonderful family who gave her a loving home!

### ASK THE TRAINER Teaching Your Dog Not To Jump

It is important to remember that dogs jump up on people because they are either looking to play, to say hello, or they are trying to get attention. Often this behavior has been encouraged throughout the dog's life from the time they are puppies. It is not an attempt to dominate you or to be spiteful. Every time the dog jumps up and the behavior is rewarded, it becomes stronger and stronger. Therefore it is important for the dog to learn that the jumping behavior will get them nothing.

#### To discourage jumping behavior:

Turn away from the dog. Stand still, cross your arms and become a "statue." If they continue, walk away from them and separate yourself either by closing a door or putting up a baby gate. Wait three to five minutes and return. If they jump again, say "Too Bad" and separate yourself.

Teach your dog a "Sit to Greet" routine. When you approach the dog, ask for a "Sit" (if they have been trained this behavior) and give them a tasty treat. Repeat with other household members or friends. Only give attention if they're seated or have all four paws on the floor.

**Remember to be consistent!**. Be sure visiting friends/family members practice these steps too. Try to avoid pushing away or scolding your dog for jumping on you, which is considered attention!
