#### TABLE VENDOR FAQ's

- **Can I bring a tent?** Yes, but it cannot be larger than 10'x10'
- Do I need to bring my own table? Only basic and non-profit vendors need to bring their own tables and chairs.
- Can I change my vendor arrival time? Please contact events@monmouthcountyspca.org and we will do our best to accommodate you.
- Is WIFI available? Unfortunately, there is no WIFI, please plan accordingly.
- Can I request my table to be near another business or preferred spot? Yes, please contact events@monmouthcountyspca.org and we will do our best to accommodate you.
- Is there an ATM on campus? Yes, there is an ATM in the Student Life Center.
- Can I bring my dog? Yes, please register your dog by contacting events@monmouthcountyspca.org or call 732-440-1548 and be sure to include your method of payment (\$10 per dog) and also a copy of his or her current rabies vaccination certificate so you don't have to wait in the vet call line.
- I am a non-profit organization, can I apply for a free table? If your non-profit has not received this benefit in the past, you may qualify for this perk. Proof of 501(c)3 status is a must!
- Are staff or volunteers available to help me unload? A limited amount of volunteers will be available to help bring your items to your designated vendor spot (they can help with ONE moving trip only). Please consider bringing a hand cart if you have heavy items.
- When is the last day that I can sign up? We can accept vendors up until the day before the event as long as payment is received upfront.

#### FOOD VENDOR FAQ's

- When is the last day that I can sign up? All paperwork and fees to the Monmouth County SPCA and also Middletown Township must be in at least 2 weeks before.
- What time should I arrive? Middletown Township usually does an inspection 2-3 hours before the event starts, please plan accordingly.
- Can I place signs in the parking lot with my menu or advertisement? Yes, of course.
- Will my food truck be the only one serving a certain type of food? We do our best to find food trucks serving different varieties.
- Is WIFI available? Unfortunately, there is no WIFI, please plan accordingly.
